### 1. PRODUCT SPECIFICATION

**Application:** Treatment of masonry by brush, course spray or injection.  
**Composition:** An aqueous solution containing 2.50% w/w 3-Iodo-2Propynyl-Butyl-Carbamate.

**Hazard:** Classified as IRRITANT under the Chemicals (Hazard Identification and Packaging) regs. 1996.  
**Appearance:** Clear pale straw coloured liquid with a mild odour.  
**Coverage:** Dilute 1 litre of concentrate with 24.0 litres of clean water. Apply 1 litre of diluted product per 2-5 square metres. For injection, dilute 1 litre with 24 litres of clean water and apply as necessary.

### 2. HANDLING/STORAGE

**Handling:** Avoid contact with eyes and skin. Use PVC gloves, goggles, respirator, protective overalls and footwear.  
**Exposure:** Only to be used by professional operators. Unprotected persons and animals should be kept away from treated areas until surfaces are dry. Ensure there is a physical barrier to prevent contact by unprotected persons and animals until treated surfaces are visibly dry.  
**Shelf Life:** 12 months.  
**Storage:** Store in original container with secure lid, in a safe place at ambient temperatures.
